

# True Potential Aggressive Portfolio

30 April 2025



## Portfolio Objective

The objective of the True Potential Aggressive Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Aggressive risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Aggressive risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Aggressive funds.

The Aggressive Investor usually aims to maximise long-term expected returns rather than to minimise possible short-term losses. An Aggressive Investor values high returns relatively more and can tolerate both large and frequent fluctuations through time in portfolio value in exchange for a higher return over the long-term.

## Investment Commentary

The True Potential Aggressive Portfolio experienced a decline of -2.57% in April.

April was a volatile month for global equities. Early in the month, President Trump's announcement of reciprocal tariffs led to a sharp market decline. However, little more than a week later expectations that these tariffs might be delayed sparked a strong rebound. Despite this recovery, US equities ended the month slightly down in local currency terms as investors considered the potential impact of tariffs on corporate profits. Emerging Markets and Japan were the best-performing equity regions, both delivering positive returns in April.

Government bond markets experienced significant fluctuations. US Treasury yields initially rose sharply following the tariff announcement but fell after the delay was announced. Shorter-dated US Treasuries delivered positive total returns as investors anticipated earlier interest rate cuts due to the expected economic slowdown from eventual tariff implementation. Global sovereign bonds, including UK Gilts and European sovereigns, outperformed US Treasuries. The US Dollar weakened further during the month, supporting a continued rise in gold prices.

The True Potential Pictet Aggressive fund was the strongest performing fund, thanks to strong performance of the Thematic equity book, including tactical tilts to their Digital and Security themes. Sterling strength against the US dollar was also beneficial. The True Potential UBS Aggressive fund was relatively challenged, as the fund's value style equities and higher dollar exposure pulled back on returns.

No changes were made to manager allocations. However, individual managers are making changes to the True Potential funds within the Portfolio. Examples include trimming exposure to US equities and rotating into European equities and increasing fixed income exposure.

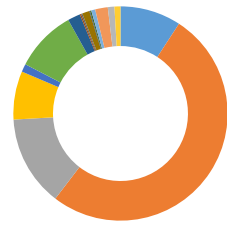

As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

### What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.71%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.14 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
