

True Potential Cautious Portfolio

Portfolio Objective

The objective of the True Potential Cautious Portfolio is to provide investors with a way to achieve their investment goals. The Portfolio offers full exposure to different manager styles within the Cautious risk profile. We review the Portfolio monthly and, if necessary, rebalance to the allocation of styles that we believe offers the best opportunity for growth within the Cautious risk profile. The Portfolio aims to produce a higher risk-adjusted outcome at a lower average cost, compared to an equally-weighted model of Cautious funds.

The Cautious Investor may be sensitive to short-term losses. A Cautious Investor's potential aversion to losses could compel them to shift into a more stable investment if significant short-term losses occur. Analysing the risk-return choices available, a Cautious Investor is usually willing to accept somewhat lower returns in order to assure greater safety of his or her investment.

Investment Commentary

The True Potential Cautious Portfolio experienced a decline of -0.52% in April.

April was a volatile month for global equities. Early in the month, President Trump's announcement of reciprocal tariffs led to a sharp market decline. However, little more than a week later expectations that these tariffs might be delayed sparked a strong rebound. Despite this recovery, US equities ended the month slightly down in local currency terms as investors considered the potential impact of tariffs on corporate profits. Emerging Markets and Japan were the best-performing equity regions, both delivering positive returns in April.

Government bond markets experienced significant fluctuations. US Treasury yields initially rose sharply following the tariff announcement but fell after the delay was announced. Shorter-dated US Treasuries delivered positive total returns as investors anticipated earlier interest rate cuts due to the expected economic slowdown from eventual tariff implementation. Global sovereign bonds, including UK Gilts and European sovereigns, outperformed US Treasuries. The US Dollar weakened further during the month, supporting a continued rise in gold prices.

The True Potential Close Brothers Cautious fund was the strongest performing fund, thanks to reducing equity and adding to gold ahead of Liberation Day, as well as strong stock selection. Sterling strength against the US dollar was also beneficial. The True Potential UBS Cautious fund was relatively challenged, as the fund's value style equities and higher dollar exposure pulled back on returns.

No changes were made to manager allocations. However, individual managers are making changes to the True Potential funds within the Portfolio. Examples include trimming exposure to US equities and rotating into European equities and increasing fixed income exposure.

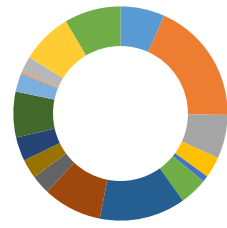
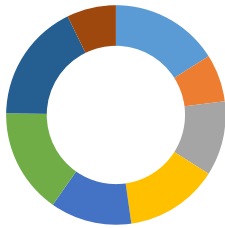

In September 2024, the FCA updated its Packaged Retail Insurance and Investment Products (PRIIPS) guidance on how we disclose costs for closed-ended funds like investment trusts. This change is designed to give you a clearer picture of the actual costs that impact your investments. As a result, some of our fund OCFs (Ongoing Charges Figure) have significantly decreased, reflecting only the costs that directly affect the fund's assets.

What are the fees associated with investing in this Portfolio?

The OCF of this Portfolio is currently 0.79%. This means that if you invest £1000 in the Portfolio, you can expect to pay £7.90 in fees over the course of a year. The fees you pay are pro-rata. If you hold the Portfolio for less than a year you will only pay the proportional amount of fees applicable (based on the duration of your investment).

Risk Type	Description
